**Change in School Calendar:** *Recommended Motion:* "Whereas, on March 7, 2020, by Executive Order 202 Governor Andrew Cuomo declared a state of emergency in New York to address the outbreak of COVID-19; and Whereas, by subsequent Executive Orders 202.4, 202.11, 202.13, 202.14, 202.18 and 202.26 ("the Executive Orders"), Governor Cuomo ordered that all schools in New York State be closed through the end of the 2019-2020 school year; and Whereas, the Executive Orders required that schools throughout New York State provide remote, alternative instruction to students during the school closures and on days in which school was not scheduled to be in session pursuant to the 2019-2020 Schalmont Central School District calendar approved by the Board of Education; and Whereas, as a result of the inclusion of these previously unscheduled instructional days, Schalmont students shall complete the required number of instructional days for the 2019-2020 school year as of June 17, 2020.
