NOTICE IS HEREBY GIVEN, that a public hearing of the qualified votes of the Schalmont Central School District at Rotterdam, will be held at 7:00 pm on June 1, 2020 through a phone in or streamed video (information provided on district website prior to the date). NOTICE IS HEREBY FURTHER GIVEN, that the annual school election of the qualified voters of the Schalmont Central School District of Rotterdam, will be provided absentee ballot applications, absentee ballots, envelopes, or any other means of transmitting an absentee ballot application or absentee ballot, including postage to voters upon the following items.

- 1. To adopt the annual budget of the School District for the fiscal year 2020-2021 and to authorize the requisite portion thereof to be raised by taxation on the taxable property of the District.
- 2. To elect three members of the Board – (2) for a three-year term commencing July 1, 2020 and expiring on June 30, 2023 and (1) for a term commencing July 1, 2020 and expiring June 30, 2022.

NOTICE IS HEREBY FURTHER GIVEN that at said Annual School District Meeting to be held on Tuesday, June, 9, 2020, the following proposition will be submitted.

**PROPOSITION I**

"Shall the proposition set forth in the notice of this meeting authorizing the purchase of five (5) school buses at a maximum estimated cost of \$475,000 and providing that such sum shall be raised by a tax levy to be collected in annual installments, with district obligations to be issued in anticipation hereof, be approved. Section 3. The School District Clerk is hereby authorized to amend the notice of the Annual School District Meeting from time to time, as in his or her discretion, such amendment may be required. Section 4. The resolution shall take effect immediately."

NOTICE IS HEREBY FURTHER GIVEN that a copy of the statement of the amount of money which will be required to fund the School District's budget for 2020-2021 may be obtained electronically by any residents of the District during business hours beginning May 26, 2020.
