**Amended School Calendar/Budget Calendar:** Motion made by Mr. Santabarbara, seconded by Mr. Thompson, that it is hereby resolved that, upon the recommendation of the Superintendent of Schools, the school calendar and budget calendar previously adopted by the Board of Education for the 2019-2020 are hereby amended as may be necessary and implemented by the Superintendent of Schools to comply with all existing and to be issued Executive Orders issued by the Governor of the State of New York that impact the school year or the operation of schools in any manner.

**Suspension of Clubs, Sports and Other Extra-Curricular Activities:** Motion made by Mrs. Hanson, seconded by Mrs. Kruk, that it is hereby resolved that, upon the recommendation of the Superintendent of Schools, that all clubs, sports, and other extra-curricular activities are hereby suspended as of April 7, 2020 until such time as the Governor orders schools to be re-opened. No duties are expected to be performed by any extra-curricular advisors or coaches during the period of suspension. The Superintendent is authorized to make exceptions to this on a case by case basis as the Superintendent may best determine. Any club that continues by authorization of the Superintendent is expected to maintain proper documentation of work done during the time of the closure”
