BOCES Cooperative Bidding: Motion made by Mr. Santabarbara, seconded by Mr. Pasquarella, whereas, a number of public school districts in the Albany-Schoharie-Schenectady-Saratoga Counties area (Capital Region BOCES) and the Washington-Saratoga-Warren-Hamilton-Essex Counties area (WHWHE BOCES) require water sampling and testing services, and WHEREAS, the Schalmont Central School district is desirous of participating with other districts in cooperatively bidding the services mentioned above, as authorized by General Municipal Law, Section 119-o, and WHEREAS, the Schalmont Central School District is a current client (subscriber) of the Health-Safety-Risk Management service offered by Capital Region BOCES, and WHEREAS, the Schalmont Central School District wishes to appoint the Capital Region BOCES to advertise for, bid, accept, tabulate bids and award bids on their behalf, therefore, BE IT RESOLVED, that the Board of Education of the Schalmont School District hereby appoint the Capital Region BOCES to represent it in all matters relating above, and designates the Daily Gazette Newspaper as the legal publication for all related cooperative purchasing bid notification, and, BE IT FURTHER RESOLVED that the Board of Education of the Schalmont School District authorizes the Capital Region BOCES to represent it in all matters leading up to and including the entering into a contract for the purchase of the above mentioned commodities and services, and, BE IT FURTHER RESOLVED that the Board of Education of the Schalmont School District agrees to (1) abide by majority decisions of the participating district (2) abide by the award of the BOCES Board; (3) and that after the award of the bid it will conduct all negotiations directly with the successful bidder(s).
