Re-appoint Superintendent of Schools: Motion made by Mr. Thompson, seconded by Mrs. Hanson, BE IT RESOLVED that the Board of Education of the Schalmont Central School District hereby re-appoints Dr. Thomas Reardon, as Superintendent of Schools, for the period July 1, 2023 to June 30, 2028, approves the Addendum to his employment agreement, dated September 25, 2023, setting forth any changes in the terms and conditions of Superintendent Reardon's employment agreement, authorizes payment thereunder, and authorizes the President of the Board to execute said Addendum on behalf of the School District.

Settlement of Vaping Litigation: Motion made by Mr. Lawrence, seconded by Mrs. Hanson, WHEREAS, the Board of Education (the "Board") of the Schalmont Central School District (the "District") previously authorized the District Superintendent to take all steps necessary to join a nation-wide lawsuit by school districts against Juul Labs, Inc. the largest seller of e-cigarettes in the United States and Altria Group, Inc. formerly known as Phillip Morris Companies, Inc. (the "Lawsuit"); and WHEREAS, in or about January 2023, counsel for Juul Labs, Inc., and counsel for the plaintiff school districts reached an agreement in principle to resolve all claims against Juul Labs, Inc., as well as its corporate representatives (the "JUUL Settlement"); and WHEREAS, the JUUL Settlement did not include the resolution or dismissal of any claims as against defendant Altria Group, Inc. formerly known as Phillip Morris Companies, Inc. (the "Altria Claims"); and WHEREAS, following extensive negotiations, counsel for Altria Group, Inc. and counsel for the plaintiff school districts have reached an agreement in principle to resolve the Altria Claims (the "Altria Settlement"); and WHEREAS, the Altria Settlement

provides, in relevant part, that in exchange for a full release of claims against Altria Group, Inc., the District will receive monetary remuneration in the amount of \$9,237.00 (the "Settlement Amount") to be paid promptly upon the execution of all necessary settlement documentation and obtaining of all necessary court approvals. NOW, THEREFORE, BE IT RESOLVED, that the Board of Education of the Schalmont Central School District hereby ratifies the Altria Settlement, a copy of which is incorporated into the minutes of this meeting, and authorizes the Superintendent of Schools to take any further actions necessary to effect the settlement authorized herein."
